PROPOSALS MAPS AMENDMENTS

EXPLANATORY NOTE (BASED ON THE BOROUGH WIDE LOCAL PLAN PROPOSALS MAPS)

Introduction

This document sets out the changes to the proposals maps contained in the Borough of King's Lynn & West Norfolk (1998) as a result of the policies in the Core Strategy Proposed Submission Development Plan Document. It updates the material used at the Proposed Submission stage by the addition of the maps themselves.

The majority of changes are shown through a series of maps but tables and text are used where necessary and appropriate to make the extent of the proposed changes clearer.

The current Proposals Map needs to be amended because:

- Some policies as listed in the Local Plan now no longer exist, "not saved" in 2007.
- "Saved" Local Plan policies have been superseded by Core Strategy policies.
- New policies areas referred to in the Core Strategy.

In addition, a number of Local Plan policies are to be retained and shown on the proposals maps until they are replaced by policies in subsequent Development Plan Documents.

The Nature of the Changes

Policies "not saved" 2007 (Table 1).

These policies have already been lost following the Secretary of State's review published in September 2007. These changes have already occurred and do not result from changes emanating from the Core Strategy. The proposals maps have now been altered to take account of these changes. Table 1 shows a list of the policies "not saved" that have been removed from the proposals maps. The relevant annotation has been struck-out in the map legend as "Not saved 2007".

"Saved" Local Plan policies, "superseded" by the Core Strategy (Table 2).

The Core Strategy Submission Document contains a number of policies that, if present in the Core Strategy that is ultimately adopted, will supersede some of the saved policies within the Local Plan.

"Saved" Local Plan Policies "Superseded" by the Core Strategy but still shown on the proposals map (Table 2).

The annotation for these policies as shown on the Proposals Map (1998) will remain to indicate further study as part of, and pending adoption of, the Site Allocations and Policies Development Plan Document.

New Policies (Table 3)

To be clear about the extent of coverage there will a new Proposals Map showing:

- areas at risk of flooding, and
- safeguarded areas and site allocations for minerals and waste
- Breckland Special Protection Area (SPA) buffer.

The new proposals map shows the extent of the areas at risk of flooding, the safeguarded areas for minerals consultation areas (from Norfolk County Council – Minerals and Waste Local Plans) and Breckland Special Protection Area (SPA) buffer in the area proposals map not the insets i.e. north, central & south. The extent of each of these subjects are currently published and available for inspection on the Borough Council or Norfolk County Council web-sites.

Also recent designations of protected areas e.g. extensions to Conservation Areas will also be identified within the final Proposals Map at the point of adoption.

The Southern Seafront Masterplan area has been added to clarify its location as a result of references made in the Core Strategy policy CS05.

Settlement Hierarchy

If a village is not provided with an inset map in the Proposals Map then it has been given a "countryside" allocation within the Borough's settlement hierarchy (Policy CS02 of the Core Strategy). Therefore these settlements have limited services and facilities and have been considered as unsustainable for additional development. As a result Built Environment type boundaries have been removed.
