The Council hereby grant permission for erection of a chalet bungalow and integral garage adj. 'Rosemead', Pious Drove, Upwell in accordance with your application dated 5 November 1987 and the plans, drawings and documents which form part of the application, subject to standard condition A set out overleaf and to the additional conditions set out below.

## CONDITIONS

- 1. The permanent space to be reserved on the site for:
  - (a) turning;
  - (b) parking;

shall be provided before the use commences and thereafter maintained.

2. The ditch/dyke along the frontage of the site shall be culverted under the proposed access to the satisfaction of the Local Planning Authority after consultation with the Drainage Authority and the Local Highway Authority.

3. Visibility splays shall be provided on both sides of the access and shall be maintained free from any obstruction over a height of 760mm, within an area of 2.5m. x 2.5m. measured from and along respectively the edge of the carriageway.
