The Council as local planning authority hereby refuse permission for the erection of an agricultural dealling

at Molls Drove, Fridaybridge in the Rural District of Wisbech, Ordnance Survey Sheet, Cambridgeshire (Isle of Ely) XIII:1, part parcel 417, (1903 Edition), scale 1/2500th, as shown on the attached plan, reference WR/72/236/0

in accordance with your Application dated 8th September, 1972

for the following reasons:

- The site is indicated as 'white' land on the approved County Development Plan within which it is intended that the existing uses shall remain for the most part undisturbed.
- 2. The site is outside the Village Development Areas for Upwell and Outwell,
- 3. The site is not shown for residential purposes on either of the new Draft Village Plans prepared for Upwell and Outwell.
- 4. The agricultural justification for the development is not so great as to warrant a departure from the normal planning policy that residential development outside willages will not be permitted.
- 5. In the opinion of the Local Planning Authority this development, if permitted, would be detrimental to the rural character and to the amenities of this area.
