The Council as local planning authority hereby refuse permission for residential development

at Robbs Chase/Isle Road, Outwell in the Rural District of Wisbech, Ordnance Survey Sheet, Cambridgeshire (Isle of Ely) XIII:1, part parcels 136 and 138, (1903 Edition), scale 1/2500th, as shown on the attached plan, reference WR/71/155/0

in accordance with your Application dated 16th September, 1971

for the following reasons:

1. In the opinion of the Local Planning Authority the site, by reason of its extremely narrow width and length, is unsuitable for re-development for residential purposes when taking into account modern standards of design, over-looking and privacy etc.
2. The proposal would be detrimental to the reasonable amenities of the surrounding area having regard to the shape of the application site.
