## Refusal of planning permission

The Council as local planning authority hereby refuse permission for residential development

at Beck Lane, Outwell in the Rural District of Wisbech, Ordnance Survey Sheet, Cambridgeshire (Isle of Ely) XIII : 13, part parcel 22 (1927 edition), scale 1/2500th, as shown on the attached plan reference WR/69/103/0,

in accordance with your Application dated 18th June, 1969,

for the following reasons:

1. The site is outside the Village Development Area for Outwell.
2. The site is shown as 'white' land on the County Development Plan.
3. There is no public sewer available to serve the site.
4. The proposal would give rise to additional highway hazards by reason of slowing, turning and waiting vehicles in the vicinity of the site.
5. Land sufficient to meet the housing requirements of this village has been approved but remains undeveloped.
