1. The estate road and the junction with the main road A.1101, shall be realigned as indicated in red on the attached plan.

2. The tree planting shown on the attached plan shall be carried out in the first available planting season after the completion of the dwellings.

3. The estate road shall be made up to the satisfaction of the Local Planning Authority prior to the occupation of the dwellings.

4. Visibility splays shall be provided at the junction of the estate road and the main road, A.1101, as indicated in red on the attached plan.

2. In the interests of the appearance of the estate.

3. In order to provide a satisfactory means of access to the dwellings prior to their occupation.
