The Wash and North Norfolk Coast European Marine Site Group



The Wash and North Norfolk Coast is designated a European marine site under UK Habitats Regulations. This designation places strong responsibilities on authorities and agencies to work closely together to safeguard nature conservation. The site extends along

the coast from north of Gibraltar Point (Lincolnshire) to just beyond Salthouse (Norfolk) and out to sea for three miles.

The Wash Estuary Strategy Group

birds. It is also home to one of Europe's largest populations of common seal.

Established in 1996, the Norfolk Biodiversity Partnership brings together local authorities, statutory agencies and voluntary groups in pursuit of a shared vision - the conservation, enhancement and restoration of the county's biological diversity.

The Partnership operates through a Steering Group which meets three times a year. In addition, eight specialist working groups have been established, dealing with: coastal biodiversity; communities and nature; ecological networks; farmland biodiversity; heathlands; waterbodies; wetlands; and woodlands.

The Norfolk Wildlife Trust



Norfolk Wildlife Trust was established in 1926. The Trust care for over 50 nature reserves and other protected sites around the county including ten kilometres of coastline, nine Norfolk broads, nine National Nature Reserves and five ancient woodlands.

West Norfolk probably has as wide a range of habitats as any equivalent area in Britain with the added bonus that the sites are accessible and all within a few miles of each other. Norfolk Wildlife Trust reserves within west Norfolk are:

East Winch Common, Grimston Warren, Holme Dunes NNR, Narborough Railway Line, Ringstead Downs, Roydon Common NNR.
