5. **Planning Reforms: Housing White Paper and more immediate changes**

Alex Fradley gave an overview of both documents which have recently been published by Government for consultation. The Housing White Paper; 'Planning for the Future' which looks at radical reform of the current planning system and will impact in the medium and long term. 6. **Local Plan Review Update**

Alex Fradley gave an update with regards to time scales. The BC are still broadly on track in terms of the timescales published in the BC's Local Development Scheme. The Local Plan review is currently being considered by Member of the Local Plan Task Group. It is currently anticipated that the Local Plan review will go before Cabinet in November and shortly after be published for the Reg.19 consultation. Following this it will be submitted for examination.

In terms of housing numbers this has gone down from around 660/700 at the time the current Local Plan was adopted to 539. This over a 15/20 year time frame makes a significant difference, the result is that the Local Plan review does not absolutely need to make any further housing allocations beyond those in the current Local Plan to meet the Borough's Local Housing Need.

7. **Neighbourhood Plans**

Alex Fradley provided an update of NP activity. There are approx. 100 parishes in the Borough and around 40 are currently engaged in the NP process. Some have adopted plans; some are reviewing these and others are close to the finish. The main message was that these had the ability to provide local development frameworks and their own policies. You can easily have the case where parishes next door to each other have direct policies to consider. Agents were

advised to join in these processes which are undertaken by the Parish/Town Councils this included commenting on policies and promoting land for development. This because the Local Plan and review leaves room for NP's to come forward and so subject to the NP basic conditions they can have their own policies. It was also highlighted the bar at examination as much lower for a NP than a Local Plan.
