Dear Katie and Martin,

I hope you are keeping well and safe during these strange times.

I am making good progress with the above examination and have nearly completed my assessment, but have not yet been able to visit the area. However, some matters have arisen on which I would be grateful for your kind assistance.

A number of queries of a factual nature or matters on which I seek further clarification or information have arisen during my review of the Neighbourhood Plan. Subject to the satisfactory resolution of these issues, I do not consider at this stage that a hearing will be needed, but this will depend on the information provided. It is not unusual at all for me to have a few queries or to ask for some further information so I'd like to reassure the Parish Council that this is quite 'normal'.

I would be most grateful if both Councils as appropriate would respond to these queries which are detailed in the attachment. I have sent you this in word format so that some of the answers may be easily added in to it if you so wish.

I would usually suggest a week or so to come back to me with the responses to maintain momentum with the examination. Mindful that Katie is on leave next week, if you are able to respond by close of business on Thursday 22 April that would be most helpful. However, with circumstances as they are, if more time is needed please do let me know and of course if things come back to me sooner, that's great.

It would be very helpful to me if all the answers could be collated together and that just one bundle of responses is sent to me by Katie at the BC please.
