Borough Council of King's Lynn and West Norfolk Responses to Matter 9 Questions

Issue 9: Is the strategy for the implementation and monitoring of the Plan appropriate and robust?

Q414. Is the monitoring framework of the Plan clear and unambiguous?

Whilst the aim of the strategy for implementation and monitoring of the Plan is clearly set out in paragraphs 16.0.1 to 16.05 of the submitted Plan [A1], it is accepted that the table at paragraph 16.0.10 does not provide sufficient detail to show how the policies within the Plan will be monitored. A main modification to replace the table at paragraph 16.0.10 is proposed to rectify this, as shown below:

Q415. Are the indicators described likely to be effective in monitoring:

- a) Progress in delivering the Strategic Objectives of the Plan; and
- b) The significant economic, social and environmental effects of the Plan?

If so, how?

Yes. The suggested main modification to the table at paragraph 16.0.10 (see previous question) sets out effective and measurable indicators that will be used to monitor the progress in delivering the strategic objectives and the significant economic, social and environmental effects of the Plan.

This will be achieved by measuring the proposed indicators for each policy from information obtained from planning applications and from the Borough's CIL Infrastructure Funding Statement. These will be reported annually and published in the Borough's Authority Monitoring Report.

As set out in paragraph 16.0.3 the purpose of monitoring are:

- to assess the extent to which policies and sites are being implemented
- to identify policies or sites that may need to be amended or replaced
- to establish whether policies have had unintended consequences
- to establish whether assumptions and objectives behind policies are still relevant
- to establish whether targets are being achieved

The monitoring information can then be used to inform any future reviews of the Local Plan.
