1. Forms of nomination may be obtained from the Returning Officer, King's Court, Chapel Street, KING'S LYNN, PE30 1EX who will, at the request of an elector for any electoral area prepare a nomination paper for signature.
2. Nomination papers must be delivered to the Returning Officer, King`s Court, Chapel Street, King`s Lynn, Norfolk, PE30 1EX on any day after the date of this notice, during normal office hours but no later than **4 pm on Tuesday 4 April 2023**.
3. If any election is contested the poll will take place on **Thursday 4 May 2023**.
4. Applications to register to vote must reach the Electoral Registration Officer by 12 midnight on **Monday 17 April**. Applications can be made online: www.gov.uk/register-to-vote
5. New postal vote applications (including proxies applying to vote by post), changes or cancellations to existing postal, postal proxy or proxy votes must reach the Electoral Registration Officer at King`s Court, Chapel Street, King`s Lynn, Norfolk, PE30 1EX by **5 pm on Tuesday 18 April 2023**.
6. New applications to vote by proxy (not postal proxy) at this election must reach the Electoral Registration Officer at King`s Court, Chapel Street, King`s Lynn, Norfolk, PE30 1EX by **5 pm on Tuesday 25 April 2023**.
7. Applications to vote by emergency proxy at this election on the grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at King`s Court, Chapel Street, King`s Lynn, Norfolk, PE30 1EX by **5 pm on Thursday 4 May 2023**. The physical incapacity must have occurred after **5 pm on Tuesday 25 April 2023**. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after **5 pm on Tuesday 25 April 2023**.
