1. John Maxey (JM) welcomed the two new members to the Informal Agents Meeting.

There were no questions or issues relating to the minutes of the previous meeting.

2. General Update on Legislation

Tim Slater (TM) raised concerns regarding BNG as Norfolk and Suffolk appear to be under-prepared. He commented that draft standing advice had been issued, but the legislation appears to have been delayed until 2024.

Hannah Wood-Handy (HWH) stated that there is going to be a Norfolk/Suffolk wide meeting to discuss resources. The assessments will be done by the Planning Officer but a suitably qualified person must prepare BNG Report.

John Maxey (JM) stated that no formal re-consultation had been done on the LP Review around BNG and the effect on densities, but presumably it will taken into consideration in the review.

HWH went on to update further on new/revised legislation;

- NPPF changes to Windfarms updated 05/09/23
- Public Rights of Way there is updated guidance
- July Chief Planners Newsletter increase in fees which suggests LPA may be able to set own fees (TS) stated that also states that Planning cannot ringfence additional income for its own use.
- Consultation on PD rights has now closed.
- Active Travel England updated 01/06/23
- Chief Planner Letter talks about u-turn on NN

- There is a further consultation on CIL

8. <u>AOB</u>

Peter Gidney (PG) said that some Agents have retired this year. Building Control are training inspectors, but they are leaving the industry. Planners are granting permission

on schemes which will not meet Building Regulations (HWH) stated that agent needs to take account as building regulations is not a planning consideration when determining applications.

- (PG) CSNN seem to be giving inconsistent advice on noise mitigation (HWH) said she will speak to them
- (PG) asked if a note could be placed on Planning Decisions regarding the Party Wall Act.
- (JM) stated that this was dealt with at the Informal Agents Meeting in March 2023 and that Planning are reluctant to do so, as it is not a planning issue.
- (HWH) suggested that changes to S73 application needs to be placed on the Agenda for the next FORMAL Agents Meeting
- (RR) Environment Agency need to attend next Formal Agents Meeting.

 - Burnham Market and Stoke Ferry passed at referendum (August/ September, respectively)
 - Gayton & Gayton Thorpe and Watlington anticipated to go to referendum November and December 2023, respectively)
 - Grimston, Roydon & Congham and Old Hunstanton anticipated to go to referendum in early-2024
 - o Overall, 6 referendums in 6 months!
