He also claimed "In particular, it should be noted that sections 4.1 and 4.2 in the submission Plan are proposed to be comprehensively replaced, including paragraph 4.1.24, to which you refer."

Although there is no further mention of brownfield in the documents presented so clearly it hasn't been replaced.
