What evidence is there to support the development of this site (G88.3), given that no development has commenced on site, planning permission for 29 dwellings has lapsed and there is no indication that a further planning application is forthcoming? A full planning application for the erection of 29 no. dwellings ,Village hall car park and associated infrastructure was submitted last year (23/01475/FM). Members resolved at Planning Committee on 9th January to grant planning permission for the proposed development subject to conditions and completion of a S106 agreement. The legal agreement is expected to be completed and the decision issued within the next week.

- 2. Have you submitted a planning application for this site? Yes, a full planning application for erection of 29 dwellings, Village hall car park and associated infrastructure was submitted last year (23/01475/FM) and received a resolution to approve at committee in January 2024.
- 3. Following receipt of Decision Notice is the development planned on this site? Yes, a decision is expected imminently and subject to discharge of pre-commencement conditions a start on site is scheduled for Sept 2024.
- 4. Has development work started on your application site? Not in relation to the current application. Start on site is expected in Sept 2024.
