I did however note you required comments regarding allocation G28.1 in Denver.

My client Fountain Construction has recently purchased the majority of this site, although I understand a section had already been sold earlier to a neighbouring property.

The site is adjacent to a listed building, and conservation raised major concerns with a scheme put forward on the site previously by a potential purchasers and there agent which was refused.

We have recently met the conservation officer on site to discuss options, and given there requirement for single storey dwellings on at least an element of the site, the protected trees on the site and the fact my client does not own the whole allocation, we believe that 8 dwellings is unrealistic, and that up to 6 would be the more likely.

We are currently in the very early stages of preparing some concept plans for the conservation officer to comment on, and hope to be coming forward with a scheme for the site shortly.
