

NOTICE OF ELECTION

UK PARLIAMENTARY ELECTION

FOR THE SOUTH WEST NORFOLK CONSTITUENCY

1. An election is to be held for a Member to serve in Parliament for the said Constituency.
2. Forms of nomination may be obtained from the (Acting) Returning Officer at the Borough Council of King's Lynn and West Norfolk, King's Court, Chapel Street, KING'S LYNN, PE30 1EX who will, at the request of an elector for any electoral area prepare a nomination paper for signature.
3. Nomination papers must be delivered to the (Acting) Returning Officer, Borough Council of King's Lynn and West Norfolk, King's Court, Chapel Street, KING'S LYNN, PE30 1EX on any day after the date of this notice between the hours of 10 am and 4 pm but no later than **4 pm on Friday 7 June 2024**.
4. The deposit (£500) for each candidate may be paid by cash or bank transfer (BACS). Bank details are obtainable from the (Acting) Returning Officer.
5. If any election is contested the poll will take place on **Thursday 4 July 2024**.
6. Applications to register to vote must reach the relevant Electoral Registration Officer by midnight on **Tuesday 18 June 2024**. Applications can be made online at: <https://www.gov.uk/register-to-vote>
7. New postal vote applications (including proxies applying to vote by post), changes or cancellations to existing postal, postal proxy or proxy votes must reach the relevant Electoral Registration Officer by **5 pm on Wednesday 19 June 2024**. Applications can be made online at: <https://www.gov.uk/apply-postal-vote>
8. Applications for a Voter Authority Certificate or an Anonymous Elector's document valid for this election must reach the relevant Electoral Registration Officer by **5 pm on Wednesday 26 June 2024**. Applications can be made online at: <https://www.gov.uk/apply-for-photo-id-voter-authority-certificate>
9. New applications to vote by proxy (not postal proxy) at this election must reach the relevant Electoral Registration Officer by **5 pm on Wednesday 26 June 2024**. Applications can be made online at: <https://www.gov.uk/apply-proxy-vote>
10. Applications to vote by emergency proxy at this election applied for on grounds of physical incapacity or for work/service reasons must reach the relevant Electoral Registration Officer by **5 pm on Thursday 4 July 2024**. The physical incapacity must have occurred after **5 pm on Wednesday 26 June 2024**. To apply on the grounds of service/occupation or employment, the person must have become aware that they cannot go to the polling station in person after **5 pm on Wednesday 26 June 2024**.
