




Hilguy Parish Council Register of Members' Interests		Notes
Name: <u>P. Bates</u> These are the interests which you are required to register with the Authority by section 30 of the Localism Act 2011 It is a breach of the Code and an offence to fail to disclose a registerable interest within 28 days of taking office with the Authority or within 28 days of declaring a new interest at a meeting. You must register your Interests and Interests of your spouse or civil partner or a person with whom you live as a spouse or civil partner.
