The Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012

Members are required to register the following disclosable pecuniary interests. Members have a disclosable pecuniary interest if it is of a description specified in No's 1-7 below and it is the Member's interest or it is an interest of the following

(i) The Member's spouse or civil partner,

(ii) A person with whom the Member is living as husband and wife, or (iii) A person with whom the Member is living as if they were civil partners,

and the Member is aware that the other person has the interest.

Members must give a description of the nature of the disclosable pecuniary interest and state whether it is their interest or an interest of a 'relevant person' described above, providing the name of the other person and the nature of their relationship to the Member. Guidance notes are attached to assist Members in completing this form.
