




WALSOKEN ..... <b>Parish Council Register of Members' Interests</b>		<b>Notes</b>
<p>Name: <u>CLIVE BETTINSON</u></p> <p>These are the interests which you are required to register with the Authority by section 30 of the Localism Act 2011</p> <p>It is a breach of the Code and an offence to fail to disclose a registerable interest within 28 days of taking office with the Authority or within 28 days of declaring a new interest at a meeting.</p> <p>You must register your interests and interests of your spouse or civil partner or a person with whom you live as a spouse or civil partner.</p> <p>This form will be published on the Borough Council website.</p> <p style="text-align: center;"><b>Registered Interests</b></p>		<p>(a) Please state in full the names of any organisations referred to rather than use abbreviations or acronyms.</p> <p>(b) Please if possible type your responses.</p> <p>(c) Where there is no interest please write "NONE".</p> <p>(d) There is no need to register "sensitive information" provided the Authority's Monitoring Officer agrees. "Sensitive information" is information which, if made public, could lead to you or a person connected to you being subjected to violence or intimidation.</p>
