The Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012

- (i) The Member's spouse or civil partner,

Members must give a description of the nature of the disclosable pecuniary interest and state whether it is their interest or an interest of a 'relevant person' described above, providing the name of the other person and the nature of their relationship to the Member. value of the shares of any one class in which the Member or the relevant person has a beneficial interest exceeds one hundredth of the total issued share capital of that class.


Any changes to the information stated above must be notified in writing to the Monitoring Officer within 28 days.


